## **Request for Permission to Publish or Publicly Use Previously Unpublished Materials Held by LSU Libraries Special Collections**

To request permission to publish or otherwise publicly use unpublished materials held by LSU Libraries Special Collections, please carefully read “**Conditions Governing Publication or Public Use of Previously Unpublished Materials Held by LSU Libraries Special Collections,**” then complete, sign, and submit Part A of this form to the Head, Public Services, Special Collections, LSU Libraries, Louisiana State University, Baton Rouge, LA 70803-3300; fax 225-578-9425.

Upon receipt of Part A, the Head of Public Services will determine if permission can be granted and, if so, what fees and other conditions will be applicable. The Head of Public Services will complete Part B of the form and return it to the requestor for his or her signature. Permission to publish or publicly use materials is not granted until Part B of the form has been properly signed by the requestor and returned to Special Collections.

### **Conditions Governing Publication or Public Use of Previously Unpublished Materials Held by LSU Libraries Special Collections**

1. This document pertains to the LSU Libraries’ rights as owner of the physical materials for which publication or public use permission is being requested. It is the responsibility of the person or organization using the material to obtain any required copyright permissions from the copyright holder, which may or may not be the LSU Libraries.
2. Special Collections will assess fees for the commercial use of materials from its collections. Special Collections reserves the right to judge whether a proposed use is commercial based on the nature of a project and its intended audience.
3. Special Collections also reserves the right to assess fees for the use of its material in non-commercial projects, in particular when use is significant or extensive.
4. Fees are negotiated on a case-by-case basis and are intended to offset a small part of the Libraries’ costs associated with processing, preserving, and providing access to its collections. If permission is granted, the fee will be specified below.
5. This fee covers only the non-exclusive, one-time use of materials specified herein for the purpose or project described above, unless otherwise indicated. The fee must be paid in advance. The fee is in addition to any duplication costs. Subsequent requests for additional use(s) must be made in writing. An additional use fee may be assessed.
6. Special Collections requires that materials be accompanied with a proper citation and/or credit line in the applicable format below:

For manuscript collections:

Name of the Manuscript Collection, Mss # [manuscript number], Louisiana and Lower Mississippi Valley Collections, LSU Libraries, Baton Rouge, La.

For University Archives:

Name of originating office followed by “Records”, RG # [record group number], Louisiana State University Archives, LSU Libraries, Baton Rouge, LA.

- “Louisiana and Lower Mississippi Valley Collections” must be spelled out the first time a collection is cited. Thereafter, the abbreviation “LLMVC” may be used. Alternately, if the author provides a list of abbreviations used, “LLMVC” may be used throughout.
- “Louisiana State University Archives” must be spelled out the first time a record group

is cited. Thereafter the abbreviation "LSUA" may be used. Alternately, if the author provides a list of abbreviations used, "LSUA" may be used.

- Picture credits may appear at the end of motion picture films and video productions.
- The publishing party will create a link to the Special Collections home page (<http://www.lib.lsu.edu/special>) from images of or credits for images published on the Internet.

***Failure to properly cite and credit Special Collections materials may result in denial of future requests.***

7. In addition to the use fee, two copies of any publication that makes use of Special Collections materials must be given to Special Collections, unless otherwise specified below.

8. Materials specified in this agreement are not to be further reproduced, sold, shared, or given to another person, company, or institution for any purpose, without the express written permission of Special Collections.

9. The applicant will defend and hold harmless Special Collections, the LSU libraries, the Louisiana State University System, its Board of Supervisors, Louisiana State University and Agricultural & Mechanical College, its officers, employees and agents against all claims, demands, costs, and expenses including attorneys' fees incurred by copyright infringements or any other legal or regulatory cause of action arising from use of Special Collections materials.
