BIOGRAPHICAL/HISTORICAL NOTE

Joseph (José) Vidal was secretary to Manuel Gayoso de Lemos, the Spanish Governor of the Natchez District, 1792-1797. Vidal later became Commandant of the Post of Concordia in Spanish Louisiana in present-day Concordia Parish, and the city of Vidalia is named for him. Vidal's daughter, Maria, married Samuel M. Davis, a planter and land speculator from Natchez, Mississippi. Davis, in partnership with his father-in-law, owned Pittsfield and Mirven plantations in Concordia Parish, Louisiana. At one time, Davis was a director of the Planters' Bank in Natchez.

Alfred Davis, son of Maria Vidal and Samuel Davis, married Sarah Surget. Sarah's father, Francis Surget Sr., was a planter and land speculator whose extensive holdings in Louisiana and Arkansas and ownership of over 10,000 enslaved persons made him one of the largest planters and enslavers in the antebellum South. Pauline Davis, daughter of Maria Vidal and Samuel Davis, married Dr. Robert Carter, who owned Lake and Vidalia plantations in Concordia Parish in the 1860s. Papers for both the Surget and Carter families also appear within the collection.

SCOPE AND CONTENT NOTE

Content Warning: Items in this collection contain historical terms, phrases, or images that are offensive, outdated, and/or harmful. These include demeaning and dehumanizing references to race, ethnicity, and nationality; enslaved or free status; physical and mental ability; and gender and sexual orientation.

The Joseph Vidal and Family Papers are arranged chronologically within each box/folder, and all manuscript volumes are placed in box 4. Oversized items have been placed in box 5. An item-level description of the contents of the collection is included in the container list.

Legal documents in the collection relate to land grants or conveyances in Louisiana, Mississippi, and Arkansas. The papers of Samuel Davis comprise the bulk of the collection and are largely land documents, bills of sale for enslaved persons (sometimes listing the names and/or ages of the enslaved), promissory notes, bills and receipts, and items related to his banking position. Francis Surget's testamentary documents are included, as are papers related to his estate. The papers of Dr. Robert Carter primarily consist of statements of accounts, bills, and receipts concerning his cotton planting activities during and after the Civil War. The correspondence in the collection dates largely from the 1860s.

Of particular interest within Vidal's papers is a letter from Joseph Vidal to Winthrop Sargent, Governor of Mississippi Territory, which refers to an impending expedition by Philip Nolan into Spanish territory without permission (October 4, 1800). The original is housed in the vault due to its fragility, but a surrogate is placed in box 1, folder 1. There are also certificates for settlement claims of land for "Hannah, a free negro woman," and "Victoria, a free negress," to land in Concordia Parish, Territory of Louisiana in 1811 (box 1, folders 4 and 5).

Within Carter's papers, items of interest include a memorandum of an agreement between Dr. Robert Carter and Frederick Scheuber for Scheuber to act as Carter's substitute in the Confederate service (1863) along with receipts of payment from Carter to Scheuber's wife, Christienne (box 3, folder 7). There is also an order directing Dr. Robert Carter to send 1/3 of his enslaved males between the ages of 18 and 50, "equipped for working on public defenses" to Harrisonburg, Louisiana (June 17, 1863).

Another letter of note is from 1852 and signed by James Foster at Hermitage Plantation. It discusses cotton, Cholera, enslaved persons, etc. (box 2, folder 11). In papers dating from after the Civil War, a letter from Elijah Smith reports unfavorably on the Freedman's Bureau and suggests that the difficulty in finding labor may force him to convert from growing cotton to hay (December 1, 1867).

Manuscript volumes include Francis Surget's account book (1837-1857) which lists money, enslaved persons, and other property given to his children, and his passport (1837-1839). Also included is Samuel Davis' account book (1843-1853) which includes expenses and memoranda of enslaved persons purchased. Loose enclosures from the volumes have been housed within box 4 with a notation as to their provenance.
