SCOPE AND CONTENT NOTE

The Natchitoches Parish Records are a collection of various legal and official records documenting the history of the parish between 1734 and 1932. They consist of notarial acts (1734-1905, undated); declarations of intention for citizenship (1820-1890); certificates of naturalization (1832-1894); marriage bonds, licenses, certificates, and registrations (1841-1901); mortgages (1840-1892); and other parish records. Also included are the records of the merchant firm of Barr, Davenport, and Murphy (1808-1810); correspondence and other records of Joseph Irwin, deputy surveyor, relative to land claims (1798-1850); and records of the Clerk of the Court pertaining to civil and criminal matters, including successions (1809-1903). Volumes of dockets of civil and criminal actions before justices of the peace in the tenth ward (1890-1932), district court bills of indictment (1880-1890), district court grand jury indictments (1886-1892), and a probate docket (1838-1907) are also included.
