BIOGRAPHICAL/HISTORICAL NOTE1

Minos D. Miller, Jr. was born in Jennings, Louisiana on September 9, 1920. He attended Louisiana State University (LSU) as an undergraduate and completed his law degree from LSU in 1947. Miller's college career was interrupted when he enlisted in the U.S. Navy. Miller was captured by the Japanese on January 3, 1945 while flying a combat mission over Formosa.

In 1953, Miller was elected as a judge to the newly created 31st Judicial District. He desegregated the jury commissions of Jefferson Davis and Allen parishes. Miller served on the Louisiana Supreme Court by special appointment. In 1968, Miller was elected to the Louisiana 3rd Circuit Court of Appeals. Miller was active in many civic, community, and church organization. He died July 1, 2006 in Jennings, Louisiana.
