BIOGRAPHICAL/HISTORICAL NOTE

Jean Charles de Pradel, a native of Uzerche, Bas Limousin, France, was a soldier and planter of New Orleans, Louisiana. He operated the Mon Plaisir Plantation and was married to Alexandrine de la Chaise de Pradel. The Pradel children were educated in France; the daughters lived there under the guardianship of the de la Chaise family. Pradel's son, Charles, was married to Marie-Louise de Cacqueray-Valmenier de Pradel.

SCOPE AND CONTENT NOTE

Letters of Jean Charles de Pradel to his family in Uzerche pertain to business matters; the development of the Louisiana colony; his Mon Plaisir Plantation; the production and trade of indigo; the education of his children; and a massacre of French colonists at Fort Rosalie by Natchez Indians and subsequent reprisals by the French (1729). Letters (1728-1769) describe the purchase and discipline of slaves and include a list (1769) of slaves with names, ages, occupations, and African nations of origin. An inventory of property of Denis-Nicholas Foucault and letters (1765-1769) describing his character are included.

Letters of Alexandrine de la Chaise de Pradel concern the administration of Pradel's estate and relations with her daughters in France. Letters of Marie-Louise de Cacqueray-Valmenier de Pradel, widow of Charles de Pradel, pertain to the settlement of her husband's estate and her own financial affairs. De la Chaise family letters from France concern the guardianship of the Pradel daughters. Some papers reflect Jean Charles de Pradel's financial affairs in France.

The collection contains photographic and typewritten copies of French archival documents pertaining to the military careers of Jean Charles and Charles de Pradel, research notes, genealogical notes on the de la Chaise family, maps of Fort d'Orleans and the Mon Plaisir Plantation, and printed items (1761-1763, 1920-1954) about Pradel and colonial Louisiana.
