#### **BIOGRAPHICAL/HISTORICAL NOTE**

Josie Thompson was born on October 6, 1916, in Rohwer, Arkansas, to Trudeau Thompson and Josie Falconer Pettit Thompson. Josie's family moved to Baton Rouge where she attended Louisiana State University (LSU), receiving a B.A. in journalism in 1937. Her older half-sister, Margaret Dixon (who later became another Louisiana journalist), assisted Josie in her early career development.

Throughout her life, Thompson served as a reporter and correspondent for numerous news outlets. In November of 1946, while employed by United Press International, Thompson travelled to Nuremberg, West Germany, to cover the Nuremberg Military Tribunal, a series of twelve military tribunals held between December 1946 and April 1949, which prosecuted German industrialists, military officers, and government officials accused of war crimes and crimes against the peace.

In 1949 she returned to the United States and, in the following year, married Samuel Henry Binder (a captain in the U.S. Army) whom she had met in West Germany. She operated her own Washington news bureau from 1949 to 1952, but later moved to New Mexico sometime thereafter where she worked as a legislative correspondent. Thompson was inducted into the LSU Journalism Hall of Fame on April 2, 1986. She died at her home in Silver City, New Mexico, on October 16, 1998, at the age of 82 and was buried at Ft. Sam Houston National Cemetery, San Antonio, Texas.

#### SCOPE AND CONTENT NOTE

The Josie Thompson Papers consist primarily of Thompson's reports on the Nuremberg Military Tribunals and other news stories that she covered while in West Germany from 1946 to 1949. Also included are photographs of the defendants in the Doctor's Trial, copies of official trial documents, writings from other journalists, and related ephemera. Personal items include newspaper clippings, letters related to her 1986 induction into the LSU School of Journalism Hall of Fame, and photos of Thompson.
